

Backflow Technical Overview



SwiftComply is a cloud-based solution accessed through a web browser without requiring additional hardware or software on the city's side.

All data and metadata belong to the Water Purveyor and are securely backed up and encrypted in transit and at rest. User access is managed through session authorization, requiring a password and email address for login.



Database Management
